

## Non-profit and Community Volunteers Honored

### The J. McKinney Willis, Jr. Community Service Award

The Society of St. Vincent de Paul, Sts. Peter and Paul Parish, received the 2013 Community Service Award for 35 years of assistance to individuals and families in need in Talbot County. This all volunteer organization gave rent assistance, utility assistance, provided shelter, distributed food and provided furniture, clothing, and housewares to approximately 400 families in 2013. The Society also started a home visitation program to accommodate the lonely and frail elderly in the community.

**Alex Handy** was recognized for his volunteer leadership throughout much of the history of The Society. His remarkable commitment and that of over 200 volunteers have enabled the organization to function with no paid staff!

#### The Town Watch Society

**Thomas Beckett** was inducted into the Society for his volunteer efforts in Kent County since 1992. Tom has been involved in and in many instances served in leadership positions in the United Way of Kent County, the Kent County Economic Development Advisory Board, the Service Core of Retired

Executives, Junior Achievement, and the Kent County Advisory Board for the Mid-Shore Community Foundation, among other organizations. Tom stands out as an exemplary leader in the community.

# Open a Fund Peter and Marianne Byrnes were the Founding Contributors to a Fund to Benefit the Immigrant Community on the Mid-Shore

Peter and Marianne's interest in the immigrant community goes back to their years in college in Miami, Florida where they met. Marianne attended Barry University which at the time was an all-girls Catholic college and Peter was enrolled at St. Thomas of Villanova University, which had been moved in its entirety from Cuba together with most of its faculty. While Peter's career with Winchester Homes in the suburban Washington area led him to appreciate how critical the immigrant community was to the construction industry, it was his volunteer experience as the owner's representative developing a new Multicultural Center and a separate day laborer and training center in Langley Park that convinced him of the need to help these workers and their families achieve their full potential.

When he finally retired in 2004, after commuting from the D.C area to Easton for seven years, he had as he likes to say "a light bulb moment" and realized that he was meant to do something similar to the Multicultural Center in Langley Park here on the Mid-Shore. Meanwhile, Marianne became involved with an initiative linked to their church to help the immigrant community in the Easton area with a focus on household support. Once Peter completed a leadership commitment with The Chesapeake Bay Trust, he and Marianne then decided to explore the need for a multicultural support center in the Mid-Shore area.

In 2011, Peter paid a visit to the Mid-Shore Community Foundation to see how we might help with his initiative. After exploring several options, Peter realized that the most immediate need was support for immigrant children and the new Chesapeake Multicultural Center was established and began its first program, homework help and youth development. Peter and Marianne note that, "the children we help in the after school program are bright and enthusiastic. Just like our own grandchildren, they love the Ravens and dislike the Steelers; they have authentic American spirit. Giving them the extra help needed to achieve their potential is a critically important community investment."

Through their generous philanthropy and their commitment of volunteer time to the new Center, Peter and Marianne have indeed made an important investment in this community. "This work is a way to honor our grandparents, all of whom were immigrants or children of immigrants. Like them, the Shore's new immigrant population is driven by the dream of a better life for their families."

The children on the cover of this report are participants in the after school program sponsored by the Chesapeake Multicultural Center at the Oasis Covenant Church in Easton.

# Roberta B. Holt Bequest funds education for Caroline County students

**Roberta B. Holt Scholarship** provides up to \$10,000 per year for a maximum of 4 years for Caroline County residents admitted to or enrolled in a two or four year post-secondary institution of higher learning, or in a licensed vocational-technical program.

Holt Dual Enrollment Grant** is available to North Caroline High School and Colonel Richardson High School juniors and seniors attending Chesapeake College while enrolled in high school. The grant covers the participant's total direct costs for attending Chesapeake College, including textbooks. Thirty-one students participated in the program in Spring, 2013.



Roberta Baxter Holt was a native of Federalsburg and a graduate of Federalsburg High School in 1959. She was a research associate in the Laboratory of Brain Evolution and Behavior at the National Institutes of Mental Health and had a long and successful career as a psychotherapist with a family oriented practice. Throughout

her extraordinary career, Dr. Holt remained connected to her Federalsburg roots. Roberta "Bobbie" Holt exemplified her personal philosophy of doing something productive every day to further yourself or humankind. This extraordinary scholarship program was established to fulfill her commitment to education and to her native Caroline County.



#### The Story of a Fund's Creation

elvyn Schofield and Edmund Lindemuth resided in Kent County and had been partners for 23 years. Edmund was a physician and had retired from the State of Maryland. His charitable interests primarily focused on animal care in Kent County. Edmund passed away in 2001. Melvyn's career had been in art and antiques. Shortly before Melvyn's death in 2012, he met with a local estate lawyer and decided to leave his residual estate to create an endowment at the Mid-Shore Community Foundation to benefit Kent County and the Mid-Shore region in perpetuity. Through the endowment, Melvyn Schofield and Edmund Lindemuth have created a legacy that will be an ongoing support to their community.

#### Financial Summary 2013

MSCF had a record setting year in 2013 with a total of \$7,448,101 in donor contributions and investment returns, an increase of 66% over FY 12. This increased overall investments in FY 13 to just under \$41 million with total assets at year end at \$46,052,245, an annual increase of 12%. The most significant factor in the growth in assets was over \$3.7 million in investment returns reflecting a very good year in the equity markets. Donor contributions were also significant at \$3.7 million due primarily to estate distributions and the large number of new funds established at the Foundation.

The Foundation also set a new record in grants and charitable expenses in FY 13—\$2,218,783! This reflects a 41% increase over last year, with a significant growth in scholarship awards contributing to that increase.

Operating expenses at the Foundation totaled \$568,000 which represented a slight increase from FY 12. Last year there were some significant one-time expenditures relating to retirement contribution adjustments and to the Bullitt House that offset modest increases in compensation for MSCF staff in FY 13. Significantly, the Foundation continues to operate very efficiently with expenses at 1.2% of assets, which is well under the level of community foundations in the same asset class.
